

AGREEMENT

about cooperation between

Kyrgyz Aviation Institute named after I.Abdraimov and Separated Structural Subdivision "Kryvyi Rih Professional College of National Aviation University" (Kryvyi Rih, Ukraine)

1. THE SUBJECT OF THE AGREEMENT

Kyrgyz Aviation Institute named after I.Abdraimov represented for Director mr. Kurmanov Ulan and the Separated Structural Subdivision "Kryvyi Rih Professional College of National Aviation University" (hereinafter referred to as the College), represented by the head of the college, Andrusyevych Anatolyi, have concluded the present Agreement with the aim of organizing mutually beneficial cooperation in the field of professional pre-higher and higher education, science and culture.

The main objectives of cooperation are: the development of interaction in the educational and cultural fields, the unification of efforts and the organization of cooperation between educational institutions in the search for problems solutions of modern professional pre-higher and higher education, science, culture and sports.

2. BASIC DIRECTIONS OF COOPERATION

The Parties of the Agreement have identified the following main areas of cooperation:

- create conditions for the implementation of common educational programs;
- exchange of work experience and information on the structure and content of professional pre-higher and higher education, as well as the exchange of specialists in these areas;
- create conditions for establishing fruitful cooperation between faculties, departments and other structural units for the applicant to receive diplomas in both educational institutions simultaneously;
- opportunity for representatives of partner education institution to take part in scientific conferences and symposia, as well as in the events of every institution connected with the celebration of anniversaries and memorable dates;
- participation in the referee of theses, publications in periodicals and other scientific publications of educational institutions;
- cooperation in co-publishing;
- exchange of scientific and pedagogical workers for lectures, consultations, internships, conducting common scientific research, as well as experiments.



- exchange of graduate students, young scientists and applicants of various educational levels for training, improvement specialization, advanced training, etc.;
- exchange of educational, methodological and scientific sources published by education institutions with bibliographic and reference literature reflecting the achievements of both educational institutions;
- attraction of leading specialists of educational institutions to work in specialized academic councils for awarding academic degrees.

3. TERMS AND CONDITIONS

Specific conditions of cooperation, the terms of implementation, research topics and other current issues are determined by the Cooperation Program (hereinafter - the Program). For its implementation, appropriate working groups are created. The duration of the Program, the conditions for its implementation and sources of financing are agreed upon by the parties additionally.

Educational institutions identify responsible representatives to coordinate activities within the framework of the Program. Every year, the results of common cooperation are published in periodicals of educational institutions with the provision of information on the relevant sites.

The current Agreement may be supplemented or amended on the conditions of mutual consensus of educational institutions. The contract also provides other forms of cooperation which may be agreed separately.

Educational institutions have agreed that according to the agreement of the parties, the Program is open to other educational or scientific institutions.

4. COORDINATION OF ACTIVITIES

The overall coordination of the parties' activities according to the Agreement is entrusted to:

- on behalf of Kyrgyz Aviation Institute named after I. Abdraimov – for Director of Institute Kurmanov Ulan;
- on behalf of Separated Structural Subdivision “Kryvyi Rih Professional College of National Aviation University” - to the Head of the college, Andrusyevych Anatolyi.

5. DURATION OF THE AGREEMENT

The term of the Agreement is 5 years. The contract comes into force from the day of its signing. The Agreement will be deemed automatically extended for the next 5 years if none of the parties declares in writing its unwillingness to continue this Agreement 6 months before the expiration of its validity.



Each party has the right to terminate the Agreement in whole or in part, in case the other party is notified in advance in writing.

The agreement is signed in three languages: Ukrainian, Russian and English.
